

EXPLANATION OF EXEMPTIONS

SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552

- (b)(1) (A) specifically authorized under criteria established by an Executive order to be kept secret in the interest of national defense or foreign policy and (B) are in fact properly classified to such Executive order;



Hello,

I have made a new report on 9/19/2024 #3147222 in hopes to get help, but I am being avoided. I have spoke with Gilroy, CA Police Department and they have urged me to continue protecting my children and to document as I have been. I am emailing you today to do a full report and prevent another falsified DCS report claiming "they can't find me" and "no evidence to substantiate".

This email contains social media content, video, audio, email and text evidence that Dominique Richards (father) is still an imminent threat to me and our children's lives. He is also spreading STDs to transgender women prostitutes, prostituting himself as a transgender woman, and attending sex parties in Chicago Illinois where he also brings drugs back into Indiana. He boldly posted an illegal website where he has caught STDs from one transgender woman.

I have **always** been honest about his police protection and the corruption. I have explained, in detail, that this is why no action has been taken by Crown Point Police Department and the Prosecutor's office since 2018. For evidentiary purposes, I have included the **six years of police reports**, **his previous felony with court-ordered anger management by the Army**, and the audio Dominique saved to masturbate to (found in 2020) of him abusing his 1st wife as well as how he used Family Court against her too. **This clearly shows Dominique has been historically abusive to women and children with zero chances of changing.**

Statements from the police claiming to have investigated the child pornography in 2020, from their parking lot (report #20CP15721), should have raised every red flag to DCS. But the Crown Point Police Department has also made statements such as:

"there's no such thing as marital rape",

"death threats are his protected right of free speech",

"if he wanted to kill you-that would be easy to do",

"those videos clearly appear edited",

"we can not make out what he is doing",

"videos do not show evidence of abuse",

"prostitution isn't illegal",

"we weren't there so we can't prove he went through with it",

"we won't go after him, I can tell you that right now!", AND

Police chanting to each other while on a phone call with me (recorded), "yeah tell her (while laughing)!"

Had I not documented all these years of abuse by Dominique Richards and the systemic abuse, I do not believe we would even be alive to contact you today about it. **Four years of asking DCS** and the **State of Indiana** to step up and keep this man from us, when will we get the help?

Imagine the shock and hurt from me reading these DCS reports stating that I am being uncooperative, unwilling to meet and listed as a perpetrator. Pardon me? I am the one who has been begging you all for help only to be met with falsified reports, purposeful neglect, and defamation of character. I have every right to be frustrated, angry, hurt and distrustful. It took Faith, Resilience and Will to survive and protect my children. It took strength and vulnerability to reach out for help knowing the stereotypes of CPS doing more harm than good, but I still tried. I still chose to ask for help.

Physically escaping him didn't stop the abuse, getting a protection order through a shelter didn't stop the abuse, in fact it has gotten worse and I never thought that was possible. The death threats via voicemails, emails, the way he is bragging online about getting away with abusing us, and tattooing himself as a badge of honor "Be My Victim" with blood dripping from it is mind-blowingly crazy! He has been able to get away with perjury under oath, destroying evidence (deleting the Twitter account @DexDexter26 AFTER evidence was submitted to the courts and police) and remotely shutting off my vehicle (the 2017 Ford Escape). He brags about having the Police, Magistrate, Attorney's, and the GAL "on payroll" and now he is emailing me he has "shooters on call"?! Hard to say he is just saying things to unnerve me when I have had Attorney's text me that his Attorney filed for a continuance and the Judge granted it only to find out that was a lie and a

violation of my constitutional rights to due process of law. I have attached the Attorney's text, the provisional order, and proof from the lienholder to show the perjury committed. In addition, the court-appointed GAL, is also blatantly ignoring the children's testimony of abuse by their father when she has the same evidence (but more) to prove what the children have stated to be true. Does she not trust her own eyes and ears or the Pediatricians?! One thing they are trying to pull is saying I am emailing myself pretending to be Dominique. Well, I must have psychic abilities because how could I email myself four days prior to the GAL filing a motion for non-compliance knowing she would file it? What reality does Lake County/Indiana operate in?!

I was trafficked in 2015 by Dominique Richards to Chicago, Illinois. Unbeknownst to me at the time that's what happened to me and that he was still married to Jessica Gabrielle Richards (Peters). In 2020, I not only found the evidence of him abusing her, but also that he would forge Army documents to miss work at Ford Motor Company to attend divorce proceedings. I was the one watching his daughter Naomi LeAnn Richards when he was "at work" covered in bruising on my throat from strangulation. I lost scholarships, my car, the ability to work, to speak to my friends, family and my parents. I wasn't even allowed to attend their funerals in 2018. I also lost two children due to the abuse. He has destroyed everything good in my life except my spirit and my Faith.

What has kept me from going public with all of this is the fact I have been protecting my children. No decent parent would want the world to watch and spread videos of their children's father abusing them and their mom. I think that bridge has formed and time to cross it. It is probably my only chance to get the protection and justice we deserve since everyone is failing us.





I am respectfully requesting all investigative material, documentation regarding any restrictions placed on my ability to contact NOPD, audio from every call with me and the names of everyone I spoke to since February 10, 2025.

As Hoosiers and visitors alike prepare for spring break travel and festivities, Attorney General Todd Rokita is calling on all Hoosiers to remain vigilant for signs of human trafficking. Spring break, a time often associated with relaxation and celebration, unfortunately provides opportunities for traffickers to exploit vulnerable individuals, particularly in areas with large crowds and tourist activity.

"Human trafficking is a modern form of slavery that thrives in the shadows, and spring break destinations can become prime targets for this evil enterprise," said Attorney General Rokita. "Whether you're traveling to a beach, a big city, or staying close to home, we need every Hoosier to be the eyes and ears in our fight to prevent human trafficking and bring perpetrators to justice."

Large gatherings and travel hubs, such as those common during spring break, are known to create increased demand for trafficked individuals forced into manual labor, commercial sex acts, or other exploitative services. People in certain roles—such as hotel staff, restaurant workers, transportation providers, and medical professionals—are especially likely to encounter trafficking victims and should stay alert.

Signs of human trafficking to watch for include:

- Individuals who appear fearful, submissive, or unable to speak for themselves.
- People living in cramped or poor conditions, or with their employer.
- Signs of physical abuse, malnourishment, or lack of personal freedom.
- Answers that seem scripted or rehearsed when questioned.
- Minors engaging in commercial sex acts, with or without overt signs of coercion.

"Spring break should be a time of enjoyment, not exploitation," Attorney General Rokita added.
"Traffickers prey on the vulnerable, and it's up to all of us to stop them. If you see something suspicious,

report to local law enforcement immediately."

If you suspect someone is being trafficked, contact local law enforcement right away or call the National Human Trafficking Hotline at 1-888-373-7888.

Hoosiers are also encouraged to visit the US Department of State's Safe Traveler's program and Travel Advisory website.

The Office of the Attorney General operates the Address Confidentiality Program, which helps protect victims of certain crimes — including those who have been trafficked — by concealing their residential address from the public and thereby their victimizers.

Dear Attorney General Nessel, As a participant of the ACP, I am submitting a formal request for a full investigation into the uncharged death of my baby and years of an extensive pattern of state-facilitated human trafficking, domestic violence, child abuse, and systemic obstruction of justice. I am the mother of a deceased baby whose death has never been investigated—despite years of documented evidence, police reports, court filings, and direct reports to authorities. In addition, the following crimes have occurred and remain uncharged or actively covered up: Human trafficking Domestic violence Child pornography Prostitution Substantiated child abuse and neglect RICO predicate acts Judicial and police corruption Civil rights violations under 42 U.S.C. §1983 In 2016, I was trafficked by Dominique Richards, while he was still on active duty in the U.S. Army. I am his second known victim. His first wife,

Jessica Gabriella Peters-Richards, was also abused in Indiana (Porter County), and I am listed in their divorce in Chicago, Illinois further proving his pattern of criminal abuse and "victim replacement." He has even tattooed his chest, "Be My Victim." Jurisdictional Misconduct: I am now being pursued by Indiana courts despite: No proof of personal service No jurisdiction under the UCCJEA Living in Michigan since 2022 and participating in the Address Confidentiality Program Yet my confidential address has now been made public via a bench warrant for "Failure to Appear" in a court that never had jurisdiction. I demand the following be answered: 1. If Indiana "could not locate me," how was I lawfully served? 2. If Michigan is my legal residence and my children's home state, where is the federally required UCCJEA communication with Michigan's courts? 3. Why has Lisa Berdine, acting on behalf of the court, appointed Sandra Moreno Garcia (her friend and former defense attorney in Case #45C01-1601-DR-000042) as the Guardian ad Litem? Why has this undisclosed conflict of interest not been addressed? State-Level Cover-Up & Political Conflicts: I have been forced to go public because Michigan authorities refuse to act and have made almost all police reports about degrading me or under the false "custody issues". Immunity is lost when public officials willfully participate in, enable, or cover up criminal conduct and violate a citizen's constitutional rights to life, liberty, and safety. NOT ALL BATTLE CREEK POLICE OFFICERS HAVE FAILED - there have been kind officers who have come out and properly detailed the reports and crimes. However, protecting a Michigan judge and her children was more important although the threatening emails had the same threats to me and my children. The closing of a known pedophile-connected "farm" in Warsaw, IN (after my protection order), which was aided by PÉTA and tens of thousands of concerned citizens. I made the report to PETA with evidence and it lead to what it is now. The political ties between Linda Ozier, local prosecutors, and domestic violence shelters are why Indiana refused to pursue charges even when Michigan authorities did. I, Cagney Theresa Richards, declare under penalty of perjury that the following is true and correct. I have never made a false police report. I have no criminal history. I do not have any mental illnesses/disorders. I am not suicidal. I am not a threat to myself or others. I am a registered participant in the Address Confidentiality Program. This is an urgent matter that cannot afford to be bureaucratically delayed. It is a life-or-death crisis for me and my children.

I have gone public to save our lives after exhausting every state and federal reporting mechanism in nearly a decade (2016-2025). I have preserved all original, unaltered evidence and am fully prepared to testify against any individuals or institutions who have organized, facilitated, or covered up nearly a decade of federal crimes against me and my children.

I submit this correspondence and the attached documentation with the utmost respect for the Department of Justice's responsibility and duty to protect the Civil and Human Rights of every American. I am writing not only as a mother, but as a survivor of state-facilitated trafficking, abuse and systemic retaliation carried out under the color of law across Louisiana, Illinois, Indiana, and Michigan.

The pattern of misconduct is not simply administrative failure. It is clearly intentional and constitutes egregious violations of constitutional and federal protections, including:

- 1. Violations of the Fourteenth Amendment Equal Protection and Due Process
- 2. Abuse under Color of State Law 42 U.S.C. § 1983
- **3.** Retaliation for Protected Activity Reporting abuse, seeking judicial redress, and filing complaints
- **4.** Suppression of Evidence and Obstruction of Public Records Including altered and falsified reports
- **5.** Weaponization of Family Court To erase federal crimes and silence the protective parent
- **6.** State-Facilitated Child Endangerment Despite clear, documented evidence of danger posed by Dominique Richards.

Despite substantiated findings of abuse, medical records, eyewitness accounts, audio/video evidence, and admissions of guilt - protection orders have been denied, evidence ignored and/or suppressed, and retaliation rapidly accelerating. I am not simply seeking justice—I am fighting for our lives!

I am formally requesting:

- A federal civil rights investigation;
- Immediate protective action for myself and my children;
- Review of attached records, including: Indiana DCS substantiations, FOIA admissions of non-investigation, and confessions from the abuser;
- Prosecution referrals where evidence supports violations of RICO, human trafficking, obstruction of justice, and civil rights crimes.

I ask plainly: If my children and I are harmed, separated, or found dead, who will be held accountable for failing to act despite overwhelming evidence? The danger is real, the timeline is public, and this letter is now a matter of record.

This is not only about my family. It is about the soul of every American family and justice. It is about the children whose cries are buried in red tape, the protective parents vilified for trying to save them, and the public servants who betray their oaths in silence. It is about the brave men and women in uniform who do not get the respect and protective they deserve due to the corruption of people such as those I am reporting.

Now, I am asking you to break that silence-to not only watch, but to act.




If the American government is sincere in its commitment to combatting human trafficking and child exploitation, it must begin by acknowledging and addressing the state-facilitated trafficking that has already been exposed within its own systems.



Attorney General Nessel has asked that the Criminal Trials Division reply to your letter. We apologize for not responding sooner. However, this office receives hundreds of letters and e-mails each week and some delays are inevitable.

The majority of the issues addressed in your letter fall within the jurisdiction of the State of Indiana. The Attorney General does not have the authority or the jurisdiction to intervene in these types of matters.

The Attorney General does not have oversight of the courts or the practice of law in the State of Michigan. If you believe that there has been misconduct by a judge you should contact the Judicial Tenure Commission at (313) 875-5110 and inquire about filing a grievance. If you believe there has been misconduct by an attorney, you should contact the Attorney Grievance Commission at (313) 961-6585.

The Attorney General also does not have supervisory control over law enforcement agencies. Most law enforcement agencies in the state have internal procedures to investigate citizens' complaints. Generally, complaints against a law enforcement agency or its officers can be resolved by following those procedures. If resolution cannot be obtained, you may wish to contact the county prosecuting attorney who has jurisdiction over the police agency involved in your complaint. You may reach the Eaton County Prosecutor's Office at (517) 543-4801.



CLAIMS AND FACTS

USDC IN/ND case 2:25-cv-00206-GSL-JEM

- 1. I am a Creole woman and a mother of two surviving minor children. I am a survivor of human trafficking, state-facilitated child abuse, systemic racism, and obstruction by law enforcement and udicial authorities. I fled Indiana in 2022, with an active personal protection order, to protect myself and my children with CPS knowledge. Since then, I have lived in Michigan, enrolled in the Michigan Address Confidentiality Program due to persistent threats. I shoulder one hundred percent of the caregiving and financial burden. I am unable to afford an attorney or travel to Indiana without jeopardizing our safety, housing, and basic needs. (Exhibit 1)
- 2. I was trafficked across state lines from Louisiana to Illinois by Dominique Richards while he was an active-duty member of the U.S. Army. He used coercion, sexual violence, financial and psychological abuse to isolate and control me. In 2016, after sustained abuse, I lost our first baby, Adyran. My child's body was improperly handled and buried without an investigation. I began reporting Dominique to law enforcement as early as January 11, 2016. Each time I sought help, I was ignored. TI1e abuse continued and worsened, resulting in repeated sexual assaults and the birth of our two sm-viving children and a miscarriage of my fourth child in 2020. (Exhibit 1)
- 3. After a forced marriage in 2017 and the birth of my first surviving child in 2018, Dominique moved us to Crown Point, Indiana. The pattern of violence, sexual coercion, and state neglect and abuse escalated! On December 29, 2018--the day of my mother's funeral-Dominique raped me. Our second su1-viving child was born from that rape in 2019. In 2020, I discovered child pornography on Dominique's computer, including searches for age-of-consent laws. I reported this to Crown Point Police and 1-:idiculed, mocked and dismissed. No action was taken. One officer I heard laughing asked the male officer next to him, "who

- 4. Indiana DCS investigated after I contacted the child abuse hotline after leaving the police station in 2020 reporting child pornography. Dominique confessed to abuse in a group text with DCS caseworkers. Indiana DCS substantiated child abuse and neglect findings against Dominique Richards. Despite this, Indiana DCS did not send this to the prosecutor. Dominique continued abusing me and our children, bragging about having "everyone on payroll" and vowing to get the children back "one way or another." In 2024, Michigan law enforcement reviewed evidence and pursued d1arges for a protection order violation. Indiana police refused to act. (PDF Exhibit 1)
- 5. Process server Darin Kinser filed a false affidavit of service claiming I had been "subserved" at a domestic violence shelter. He named a shelter advocate, Abby Bennett, who allegedly confirmed my residency. This was a lie. Emails from the Indiana Coalition Against Domestic Violence (ICADV) and the shelter director confirm that no such service is recognized or legally valid. They explicitly stated that they do not confirm or deny the presence of anyone in shelter, and that "subservice" is not a valid form of legal service in Indiana. This perjury was used to manufacture jurisdiction. (Exhibit 2)
- 6. Attorney Kristina Lynn Garza, representing Dominique Richards, admitted in court that Dominique opened and used my private mail-while under a protection order-to track me. This violates federal mail fraud and stalking laws. Garza submitted knowingly false financial documents to the court to help Dominique avoid child support and hide assets. She also submitted a false date of separation to manipulate jurisdiction. On top of this, she facilitated the destruction of social media evidence that included Dominique's admissions of abuse, promotion of prostitution, and plans to use the family court for retaliation. Garza has refused to comply with discovery. (Exhibit 3)
- 7. Guardian ad Lltem Sandra Moreno Garcia, appointed by Magistrate Berdine, never visited my home in Michigan or met the children in person. She knowingly withheld reports of abuse disclosed by the children dming virtual interviews. Emails, recordings, and an official statement from the Director of Mid-America Psychological Services confirm she fabricated a mental health compliance story by falsely claiming I refused a sliding-scale evaluation that never existed. The only two meetings we had were on Zoom, and both are recorded. (Exhibit 4; Audio Exhibit 1)

- 8. The Crown Point Police Department fabricated records for over seven years. Despite dozens of reports regarding rape, trafficking, domestic violence, and child abuse-including the stillbirth of my child-they repeatedly claimed there was "no evidence" and closed cases without investigation. A FOIA response confirmed that no investigations were ever opened-not even into the improper burial of my baby or the reported rapes that resulted in pregnancies. They labeled known child pornography on Dominique's device as "legal." Michigan authorities, by contrast, reviewed the same evidence and took immediate action. They pursued charges for protection order violations, referred 1ne to the FBI and DOJ, and issued a child safety plan recommending no contact between Dominique and the children. Michigan CPS advised that I seek emergency custody and confirmed I was eligible for the :tvlichigan Attorney General's Address Confidentiality Program. (Exhibit 5)
- 9. Magistrate Lisa Ann Berdine ignored all this evidence-DCS substantiation, Michigan charges, CPS safety plan, forensic threats, and even Dominique's tattoo that reads "Be My Victim." She struck my filings for alleged procedural defects despite accepting the same format previously. She refused to acknowledge admitted criminal conduct from Garza, including mail fraud and stalking. She marked me as a no-show on February 19, 2025, even though I called the court and submitted proof I was present. On December 19, 2024, she issued a bench warrant that led to the loss of my job and business license. Her rulings reflect the threats sent to me from a TutaNota email I believe was sent by Dominique. (Exhibit 6)
- 10. Since 2022, I have published my evidence publicly. Over 40,000 people have signed a petition demanding prosecution. My FOIA requests expose deep cover-ups, and I have helped close a pedophile farm in Warsaw, Indiana by reporting it to PETA. Despite overwhelming proof, Indiana continues to suppress evidence, protect my abuser and retaliate for me exposing the racism and corruption.
- 11. I have suffered severe financial loss, career damage, emotional trauma, and loss of a child. My two surviving children traumatized and robbed of their innocence, still in danger of being returned to the same fate as their sibling. I have never made a false report. I have followed every lawful channd. Michigan believed me. Indiana buried the truth. I believe this is because I am a Creole woman of color and my children are "Black" because how we are treated in comparison to Dominique Richards first victim, a White woman, is quite clear. This is racial discrimination, obstruction, and trafficking-shielded by family court process.

OPINION AND ORDER

Cagney Richards, proceeding pro se, moves for leave to proceed in forma pauperis on a complaint she brings against Dominique Richards, Magistrate Lisa Berdine, attorney Sandra Moreno Garcia, attorney Kristina Lynn Garza, process server Darin Kinser, and the Crown Point Police Department. [DE 2]. For the reasons below, the Court denies the Motion to Proceed In Forma Pauperis and dismisses the Complaint [DE 1] with leave to refile.

Discussion

Ordinarily, a plaintiff must pay a statutory filing fee to bring an action in federal court. 28 U.S.C. § 1914(a). An indigent party may commence an action in federal court, without prepayment of costs and fees, upon submission of an affidavit asserting an inability "to pay such fees or give security therefor." 28 U.S.C. § 1915(a). Here, Plaintiff's Motion [DE 2] establishes that she is unable to prepay the filing fee. That said, the Court must now examine whether her action is frivolous or malicious, fails to state a claim for which relief may be granted, or seeks monetary relief against a defendant who is immune from such relief. 28 U.S.C. § 1915(e)(2)(B); *Luevano v. Wal-Mart Stores, Inc.*, 722 F.3d 1014, 1018, 1027 (7th Cir. 2013). In making that inquiry, this Court follows the Supreme Court's direction that "a pro se complaint, however

inartfully pleaded, must be held to less stringent standards than formal pleadings drafted by lawyers." *Erickson v. Pardus*, 551 U.S. 89, 94 (2007) (quotation marks and citations omitted). Even so, that deference is not unlimited. Allegations must give rise to cognizable claims over which this Court may exercise jurisdiction. A federal court can hear claims that either (1) arise under the Constitution or implicate federal law, or (2) establish diversity jurisdiction, i.e., no plaintiff or defendant is a citizen of the same state, and the claimed damages exceed \$75,000. *Page v. Democratic Nat'l Comm.*, 2 F.4th 630, 634 (7th Cir. 2021); 28 U.S.C. § 1332(a).

The maxim that federal courts are "courts of limited jurisdiction" applies to all litigants. See Kokkonen v. Guardian Life Ins. of America, 511 U.S. 375, 377 (1994). One such limitation comes from the domestic-relations exception, which "divests the federal courts of [the] power to issue divorce, alimony, and child custody decrees." Ankenbrandt v. Richards, 504 U.S. 689, 703, (1992). In Neitzke v. Williams, the Supreme Court said that a complaint is frivolous under § 1915(e)(2)(B)(i), formerly § 1915(d), when it lacks "an arguable basis either in law or in fact." 490 U.S. 319, 325 (1989). A claim lacks an arguable basis in law when it rests on a meritless legal theory. See Neitzke, 490 U.S. at 326. For example, it is frivolous to assert a claim rooted in a nonexistent legal interest. Id. at 327. Asking a court to accept something it is without the power to adjudicate is another example. Based on the Complaint, it appears that Plaintiff is seeking to remove her divorce matter to federal court. See, e.g., [DE 1, Page 8] (in a section titled, "Requested Relief," Plaintiff asks that the Court "accept removal"). If that is Plaintiff's primary aim, the Court dismisses the Complaint [DE 1] with prejudice. A pending divorce action falls squarely within the domestic-relations exception, so it is therefore beyond this Court's power to decide. Under § 1915(e)(2)(B)(i), such a cause is frivolous and must be dismissed.

On top of seeking removal, Plaintiff seemingly alleges wrongdoing by private individuals, state employees, and state agencies prior to, and during the course of, the pending divorce action. [DE 1]. To the extent that is the case, each of those potential claims also fail.

One claim appears to be for monetary relief against Magistrate Lisa Berdine. [Id.]. Under § 1915, the Court shall dismiss a complaint when it "seeks monetary relief against a defendant who is immune from such relief." 28 U.S.C. § 1915(e)(2)(B)(iii). "A judge has absolute immunity for any judicial actions unless the judge acted in absence of all jurisdiction." Polzin v. Gage, 636 F.3d 834, 838 (7th Cir. 2011). "A judge will not be deprived of immunity because the action [taken] was in error, was done maliciously, or was in excess of [her] authority[.]" Stump v. Sparkman, 435 U.S. 349, 359 (1978). Further, a plaintiff is not allowed to seek injunctive relief against state and federal judges under § 1983. 42 U.S.C. § 1983; see Johnson v. McCuskey, 72 F. App'x 475, 477 (7th Cir. 2003). Here, Plaintiff appears to fault Magistrate Berdine for the alleged shortcomings of the guardian ad litem. [DE 1, ¶ 7]. She also alleges that Magistrate Berdine ignored evidence, improperly struck filings, and issued a bench warrant against Plaintiff that caused the loss of Plaintiff's job and business license. [Id., ¶ 9]. To this Court, the latter allegation appears to be the only one concerning Magistrate Berdine on which Plaintiff seeks any form of relief: "[Plaintiff requests] financial compensation for job loss due to bench warrant." [Id., Page 8]. Given that Plaintiff seeks monetary from Magistrate Berdine, who is immune from such relief, it is only appropriate that this Court dismiss all such claims against Magistrate Berdine with prejudice.

As for the remaining allegations, the Court struggles to discern what, if any, claims exist within this complaint. Under § 1915(e)(2)(B)(ii), the Court shall dismiss an action that "fails to state a claim on which relief may be granted[.]" The standard for dismissing a complaint under §

1915(e)(2)(B)(ii) is the same standard as that for dismissing a complaint under Federal Rule of Civil Procedure 12(b)(6). Coleman v. Lab. & Indus. Rev. Comm'n of Wisconsin, 860 F.3d 461, 468 (7th Cir. 2017). To survive dismissal, a "complaint must contain sufficient factual matter, accepted as true, to state a claim to relief that is plausible on its face." Ashcroft v. Iqbal, 556 U.S. 662, 678 (2009) (cleaned up). "A claim has facial plausibility when the plaintiff pleads factual content that allows the court to draw the reasonable inference that the defendant is liable for the misconduct alleged." Iqbal, 556 U.S. at 678 (citing Bell Atl. Corp. v. Twombly, 550 U.S. 544, 556 (2007)). Yet for each of the remaining defendants, the Complaint fails to allege sufficient factual matter that states a facially plausible claim for relief. There are no allegations sufficient to establish or support diversity jurisdiction. And, even if it squints, the Court struggles to see any claims that arise under federal question jurisdiction. Only two instances of alleged conduct approach such claims: (1) the alleged failure to investigate by the Crown Point Police Department, and (2) and the alleged mail fraud of her husband, Dominique Richards. As it stands, these are both pleaded as conclusory statements untethered to a concrete injury. This is not enough to adequately state a claim for relief. For those reasons, any claims against defendants other than Magistrate Berdine are dismissed without prejudice.

Conclusion

Accordingly, for reasons stated within this order, Plaintiff's Motion to Proceed In Forma Pauperis [DE 2] is **DENIED**. Consequently, the Complaint [DE 1] is **DISMISSED WITHOUT PREJUDICE** except for claims for monetary relief against Magistrate Lisa Berdine, which are **DISMISSED WITH PREJUDICE** under § 1915(e)(2)(B)(iii). Plaintiff is given until July 7,

2025, to reapply to proceed in forma pauperis and to file an amended complaint, which may not

seek removal of a pending domestic-relations matter. If Plaintiff fails to timely refile, the Court will direct the Clerk to close the matter without further notice to Plaintiff.





Patrice,

I called your office directly, you heard my voice and transferred me to your receptionist. You absolutely had my number and chose not to use it. This isn't victim advocacy. It's reactive damage control.

It's astonishing how quickly you managed to respond now that I made it clear I was prepared to escalate and report your conduct, yet for over a year and a half, there was no urgency, no follow-up, and no effort to respond to my consistent outreach. Now you state "it takes time" to send documents, despite your assistant Veronica clearly stating via email that "everything that could be sent was sent." Which is it? Either the file was complete, or you're scrambling now that the threat of accountability is on the table.

I intentionally withheld filing formal complaints until after notifying you because I knew it would expose both intent and negligence. The same way I used the Indiana federal civil rights lawsuit to prove Valparaiso alumni corruption in NWI. There is a clear pattern I've encountered from nearly every agency involved for nearly a decade. My integrity and kindness is clearly mistaken for ignorance.

The fact that Dominique Richards filed for divorce in Indiana on December 29, 2023 does not create jurisdiction without service. It also does not erase that Michigan Child Protective Services advised me to seek emergency custody as early as August 2023. You have multiple safety plans from Michigan authorities outlining clear no-contact directives. You viewed the same videos I submitted showing him smothering my daughter. You had more than enough evidence to recognize and act upon the federal crimes committed against me and my children. It is also alarming that a man can break into a domestic violence shelter, threaten their staff and be aggressive yet that is deemed proper service to Michigan and improper to Indiana, but a moot point because both states refused to act and protect us so now "the case has gone on for so long". That's textbook manufacturing of jurisdiction and at the heart of it's usage and defense are two federally funded organizations meant to combat this very problem. The irony!

The Battle Creek Police Department pursued charges against Dominique Richards for violating a protection order. It was your negligence that allowed him to appear at my front door, literally. Indiana refused to pursue charges, as always, to protect him. The APRA request and response from Crown Point Assistant Chief James Janda in February 2025 confirms this pattern, it is attached.

Under both the UCCJEA and TVPA, you had a legal and ethical obligation to act or to direct me to someone who could. Why would a federally funded organization, tasked with assisting domestic violence and human trafficking victims, ignore clear evidence of state-facilitated trafficking disguised as "family court"? It's rhetorical. I already know the answer.

Attached is the latest follow-up from Senator Todd Young's office and the APRA request and response referenced above. I have also attached some Battle Creek Police Department reports. Their reports reflect

that Dominique, or anyone on his behalf, is allowed to call in welfare checks as often as they like, and if I call to ask the police to make it stop, I am just calling to complain about every problem in my life and how the FBI won't help.
